Aa. whereas the recently published Joint Research Centre report entitled ‘Modelling environmental and climate ambition in the agricultural sector with the CAPRI model: Exploring the potential effects of selected Farm to Fork and

Biodiversity strategies targets in the framework of the 2030 Climate targets and the post 2020 Common Agricultural Policy' concludes, together with other recent studies, that the implementation of the strategy's targets would substantially impact agricultural production in the EU; whereas these studies underline the need for robust, scientific ex ante impact assessments, covering sustainability from the economic, social and environmental perspectives and the need to take into account cumulative effects, possible trade-offs, the availability of the means to achieve the targets and different farming models across the Member States as part of any legislative proposals under the Farm to Fork Strategy;
